LIMITED WARRANTY (1) YEAR WARRANTY

PROKRAFT INC "PRO-CUT" WARRANTS THIS PRODUCT AGAINST DEFECTS IN MATERIALS OR WORKMANSHIP FOR A PERIOD OF ONE YEAR FROM THE DATE OF ORIGINAL PURCHASE.

Should any manufacturing defect be discovered within one year from date of purchase, you must deliver the entire product to the PRO-CUT dealer that sold it or to a PRO-CUT service center in its original packaging or in packaging affording an equal degree of protection, along with proof of purchase. PRO-CUT will at its option, repair or replace on an exchange basis with an equal or equivalent unit. The defective unit, without charge for parts and labor. The transportation and insurance charges to and from the PRO-CUT service center are not included in this warranty.

What this warranty does not cover.

This warranty covers only normal consumer use in Canada and the United States. This warranty does not cover worn parts, which due to the nature of the machine, have a limited usable life, and have to be replaced on a use and wear basis, nor:
